 - (5) Do not envelope. If you select a greater number of candidates than there are vacancies to be filled, your ballot will be void for that public office or party position or proposal.

- (1) If you have, or obtain, or attempt to obtain this ballot, return it now to the election inspector. Do not attempt to correct mistakes on the ballot by making erasures or cross-outs. Changes or cross-outs may invalidate all or part of your ballot. Prior to submitting your ballot, if you make a mistake in completing the ballot or wish to change your ballot choices, you may obtain and complete a new ballot. You have a right to a replacement ballot upon return of the original ballot. Submitting your ballot, except to the election inspector and mail for the right that your ballot has been successfully received. If no such notice appears, meet the accuracy of the election inspector.

- (7) Do not check any box. If you select a greater number of candidates than there are vacancies to be filled, your ballot will be void for that public office or party position or position.
