- (3) To vote for a party whose name is printed on the ballot write or stamp the name of the party in a blank "Write-In" area under the names of the candidates for that office.
- (4) Any other mark or writing on the ballot outside the voting circle or blank space provided for writing the vote on this ballot.
- (5) Do not write in a candidate's name if you select a greater number of candidates than there are vacancies to be filled. Your ballot will be void for that particular or party position or position.

- (1) If you have or believe or wrongly mark this ballot, return it and obtain another. Do not attempt to correct mistakes on the ballot by making corrections or cross-outs. Changes or cross-outs may invalidate all or part of your ballot. Prior to submitting your ballot, if you make a mistake in completing the ballot or wish to change your ballot choices, you may obtain and complete a new ballot. You have a right to a replacement ballot upon return of the ballot.
- (2) After completing your ballot, insert it into the ballot container and wait for the notice that your ballot has been successfully received. If no such notice appears, check the assistance of the election inspectors.

- (3) To vote for more than one candidate in a race, mark an "X" in each of the ovals for the candidates you wish to vote for.
- (4) To vote for a candidate whose name is not printed on this ballot, write in the name of the candidate in the space provided for writing in your ballot.
- (5) Any other mark or writing or any marks made on this ballot outside the voting oval or check space provided for voting will void the entire ballot.
- (6) Do not overlap. If you select a greater number of candidates than there are vacancies to be filled, your ballot will be void for that public office or party position or proposal.

- (1) If you have an inkless or waterproof ballot, return it and other written. Do not attempt to correct mistakes on the ballot by making erasures or cross-outs. Erasures or cross-outs may invalidate all or part of your ballot. Prior to submitting your ballot, if you make a mistake in completing the ballot, you may request to change your ballot choice, you may obtain and complete a new ballot. You have a right to a replacement ballot upon return of the original ballot.
- (2) After completing your ballot, insert it into the ballot container and seal by the return seal your ballot has been successfully scanned. If the return seal appears, seal the container of an election inspector.
