Local Law No. 9 of 2002 is amended as follows:

1. Paragraph 2 of said local law, entitled "Abolishment of Certain part-time positions," is hereby amended to read as follows: "Abolishment of Certain positions. The following positions are hereby, or shall remain, abolished: E.M.S. Coordinator, Part-time Director of Emergency Management, Part-time 911 coordinator, Part-time County Fire coordinator."
2. Paragraph 4(a) of said local law, entitled "Duties," is amended as follows: At the end of said paragraph, a sentence shall be added, stating that "The Director of Emergency Management shall also perform the duties of E.M.S. Coordinator; this shall not result in any additional salary, pay or other benefits to said Director of Emergency Management."

This local law shall take effect immediately upon its filing with the Secretary of State.
