Call to Order

Chairman Hayssen called the meeting to order at 5:35 p.m.

Roll Call of Members by the Clerk

Twelve members of the Seneca County Board of Supervisors answered roll call. Supervisor Lafler and Supervisor Reynolds were not present.

Pledge of Allegiance and Moment of Silence

Reports of Standing Committees

Personnel Committee - Mr. Earle, Chairman. The Committee met on December 17, 2014 and voted in favor of a resolution introducing and advertising a public hearing for proposed Local Law 1 of 2014 to establish salaries of certain public officials whose compensation changes in the middle of the current term.

Public Health Services Committee - Mrs. Garlick Lorenzetti, Chairwoman. At a meeting on December 1, 2013, the Committee approved a board resolution authorizing the Chairman of the Board of Supervisors to execute a contract with Lauren Taylor for speech therapy services for the Pre-School Program. The Committee also approved refilling the position of a Public Health Nurse. The Public Health Director is seeking a candidate with a Bachelor's Degree, but will consider a registered nurse.

Government Operations - Mr. Westfall, Chairman. On December 17, 2014, the Committee met and passed a motion to move forward to refill the County Manager position. The Board of Supervisors Chairman is authorized to appoint members to a search committee.

Chairman's Remarks

Chairman Hayssen stated that County Manager Mitch Rowe would be leaving his position to work for the City of Rochester, NY effective January 6, 2014. The Chairman recognized IDA Executive Director Robert Aronson. Mr. Aronson, under the direction of Chairman Hayssen, compiled a list of several projects of which Mr. Rowe was "absolutely integral" and praised Mr. Rowe for his work and achievements during his tenure first as the Planning Director and then as County Manager for Seneca County.

Chairman Hayssen opened the floor to receive comments from members of the county staff and members of the Board of Supervisors about working with Mr. Rowe. Recognized by Chairman Hayssen: Human Services Commissioner Charles Schillaci; Democratic Election Commissioner Ruth Same; Sheriff Jack Stenberg; Personnel Director Kathy Corona; Seneca County Community Counseling Services

Director Scott LaVigne; District Attorney Barry Porsch; County Historian Walter Gable; Supervisors Kaiser, Prouty, Davidson, Earle, McGreevy, Churchill, Westfall and Garlick Lorenzetti.

County Manager Remarks

Mr. Rowe thanked everyone for the praise and recognition. He was hired by Seneca County as its Planning & Community Development Director for 3.5 years and was appointed as the County Manager for 2 years. He thanked the Board of Supervisors for its trust and confidence when they appointed him to the position of County Manager. He said he will be available to the Board of Supervisors for as long as they need him. He would be getting files in order by the next week.

County Attorney's Remarks

Mr. Fisher said the case between Seneca County and Cayuga Nation dealing with unpaid property taxes and foreclosure proceedings was scheduled to be heard before the Second Circuit Court of Appeal in New York City on January 7, 2014.

A brief discussion took place among the Board of Supervisors and the County Attorney about coordinating a group to attend the hearing.

BOARD OF SUPERVISORS APPOINTS COUNTY OFFICIAL TO EXERCISE DUTIES OF PURCHASING DIRECTOR

RESOLUTION NO. 253-13 moved by Mr. Westfall; second by Mr. Shipley and adopted by 633 ayes and 117 not present (Reynolds, Lafler).

WHEREAS, Seneca County Policy §§202.100 and 202.101 authorize the County Manager as Purchasing Director to approve certain purchases and budget transfers for purposes of effecting such purchases; and

WHEREAS, County Policy permits any other officer of the County duly appointed by resolution of the Board to approve such purchases and budget transfers; and

WHEREAS, the current County Manager’s resignation is effective January 6, 2014; and

WHEREAS, in the interim, the Board desires to appoint a County Officer to fulfill the duties of the Purchasing Director encompassed under those sections; now, therefore be it

RESOLVED, that the Board of Supervisors hereby appoints the County Treasurer as the County Officer to act as Purchasing Director solely for purposes of executing the duties of the Purchasing Director and the County Manager defined under §§202.100 and 202.101 of the County Policy Manual related to purchasing and budget transfers; and be it further

RESOLVED, that upon the appointment by the Board of Supervisors of a new County Manager such duties shall, without further action by the Board, revert to the County Manager so appointed

BOARD OF SUPERVISORS AUTHORIZES PURCHASE OF 2014 FORD F250

RESOLUTION NO. 254-13 moved by Mr. Kaiser; second by Mr. Davidson and adopted by 633 ayes and 117 not present (Reynolds, Lafler).

WHEREAS, funding is available in the 2013 Seneca County Budget for the purchase of a replacement vehicle for the County Facilities operations; and

WHEREAS, a replacement vehicle is necessary and appropriate for the facilities fleet; and

WHEREAS, a 2014 Ford F250 is available on New York State bid pricing from Van Bortel Ford, 71 Marsh Road, East Rochester, New York 14445, in the amount of \$28,776.78; and

WHEREAS, this resolution is recommended for approval by the Public Works Committee at a meeting on December 17, 2013; now, therefore, be it

RESOLVED, that the Board of Supervisors authorizes the purchase of a Ford F-250 from Van Bortel Ford in an amount not to exceed \$28,776.78.

CHAIRMAN OF THE BOARD OF SUPERVISORS AUTHORIZED AND DIRECTED TO SIGN A CONTRACT WITH LAUREN TAYLOR FOR THE PRE-SCHOOL PROGRAM

RESOLUTION NO. 255-13 moved by Mrs. Garlick Lorenzetti; second by Mr. Earle and adopted by 633 ayes and 117 not present (Reynolds, Lafler).

WHEREAS, the Health Department is required to contract with professionals to provide services for children enrolled in the Pre-School Program; and

WHEREAS, there is a need for speech therapists to meet the demands in this program; and

WHEREAS, Lauren Taylor, Speech Therapist, White Springs Lane, Geneva, NY would like to contract with Seneca County to provide these services; and

WHEREAS, the money is in the Public Health Budget 104149 54700; and

WHEREAS, the Public Health Committee authorized this contract at a meeting on December 17, 2013; now, therefore be it

RESOLVED, that the Chairman of the Board of Supervisors is hereby authorized and directed to sign a contract with Lauren Taylor to provide services for the Pre-School Program.

RESOLUTION ADDRESSING MANAGEMENT BENEFITS

RESOLUTION NO. 256-13 moved by Mr. Earle; second by Mr. Westfall and adopted by 508 ayes, 125 nays (Churchill, Kubasik) and 117 not present (Lafler, Reynolds).

WHEREAS, the Personnel Committee met on December 17, 2013 and agreed that there is a practice whereby management employees follow the CSEA contract regarding certain benefits; and

WHEREAS, the recently ratified CSEA Memorandum of Agreement changed some of these benefits; and

WHEREAS, there is no policy or procedure defining the practice of management employees following the CSEA contract regarding certain benefits; now therefore be it

RESOLVED, that the Board of Supervisors acknowledges and approves of management employees following the CSEA contract regarding health insurance contributions, opt-out provision, and mileage rate; and be it further

RESOLVED, that the Board of Supervisors supports the creation of a policy addressing specific management benefits.

Prior to the adoption of Resolution 256-13, the Personnel Director Kathy Corona explained that although there wasn't a formal policy stating so, guidelines for mileage rate and health benefits for management employees were the same as union employees. It was the desire of certain board members to formalize the practice by a resolution. Discussion points included changes to the mileage rate by increasing the mileage rate from \$0.43 to the IRS mileage rate of \$0.565 for 2013 (retroactive to January 1, 2013) and the IRS mileage rate of \$0.56 for 2014; and that new hires will be responsible for 20% of health insurance or allowed to choose a buy-out option.

Chairman Hayssen recognized Supervisor Kubasik who moved the previous question; seconded by Supervisor Kaiser, and carried by a two-thirds majority vote.

RESOLUTION PROVIDING 2% INCREASE TO NON-REPRESENTED EMPLOYEES

RESOLUTION NO. 257-13 moved by Mr. Earle; second by Mr. Kaiser and adopted by 633ayes, and 117 not present (Reynolds, Lafler).

WHEREAS, employees that are not represented by a union, have not received a salary increase since January 1, 2012; now, therefore be it

RESOLVED, that the Seneca County Board of Supervisors approves a 2% salary increase effective January 1, 2014 for those employees who are not represented by a union and whose titles are not included on a salary schedule.

Prior to the adoption of Resolution 257-13, Personnel Director Kathy Corona, at the request of Supervisor Kubasik, that the resolution is intended for employees who are not in a Step Program and not represented by any union. The last time these positions received a salary increase was January 2012.

RESOLUTION PROVIDING SALARY INCREASES TO MANAGEMENT EMPLOYEES

RESOLUTION NO. 258-13 moved by Mr. Earle; second by Mr. Westfall and adopted by 633ayes, and 117 not present (Reynolds, Lafler).

WHEREAS, Seneca County Policy 102.100 Job Evaluation/Management Salary System provides for merit increases for management employees; and

WHEREAS, said merit increases are based upon performance evaluations; and

WHEREAS, in 2013 a Management Performance Evaluation Process was undertaken in anticipation of management employees receiving step increases based on merit; and

WHEREAS, this policy addressing step increases has not been utilized since 2006; now therefore be it

RESOLVED, that the Seneca County Board of Supervisors acknowledges Seneca County Policy 102.100 and shows its intent to follow said policy in the future; and be it further

RESOLVED, that the Seneca County Board of Supervisors approves step increases effective January 1, 2014 for management employees who have not been previously approved to move to the market rate in 2014 and receive an evaluation of at least 3.0 on a scale of 5.0; and be it further

RESOLVED, management employees that are at step 15 will receive an increase equal to that of a step; and be it further

RESOLVED, that full-time Elected Officials, Election Commissioners and Deputy Election Commissioners will automatically move a step higher since they are evaluated by the electorate or political parties.

A RESOLUTION TO INTRODUCE PROPOSED LOCAL LAW A OF 2014 TO ESTABLISH THE SALARIES OF CERTAIN COUNTY OFFICIALS

RESOLUTION NO. 259-13 moved by Mr. Earle; second by Mr. Westfall and adopted by 633ayes, and 117 not present (Reynolds, Lafler).

WHEREAS, the Board of Supervisors has approved the County Budget for 2014; and

RESOLVED, that copies of the aforesaid proposed local law be laid upon the desks of each member of the County Board; and, be it further

RESOLVED, that the County Board of Supervisors hold a public hearing on said proposed Local Law at the Board of Supervisors' Room at the Seneca County Office Building, 1 DiPronio Drive, Waterloo, New York at or about 5:30 P.M. on January 15, 2014; and be it further

RESOLVED, that a special meeting of the Board of Supervisors will be held January 15, 2014 in the Board of Supervisors Room of the Seneca County Office Building at 5:30 P.M. for purposes of conducting such public hearing, taking action thereafter with regard to such proposed Local Law as deemed appropriate and to transact such other business as may come before the Board; and it is further

RESOLVED, that the Clerk of the Board publish or cause to be published a notice of said public hearing in the official newspapers of the County at least five (5) days prior thereto.
