Terminal area projects include the construction of a terminal access road, a 10,000 sq. ft. t-hangar, an 8,000 square foot conventional/corporate hangar, and apron modifications. The action will also involve the acquisition of an easement over approximately 27 acres of land within Runway Protection Zone (RPZ) to Runway 1, and within the Towns of Fayette and Seneca Falls, to protect navigable airspace in accordance with FAA requirements.
