Amended Site Plan Review
Lago Resort and Casino Project
Route 414

This application under the Town of Tyre PUD Law is for a modification of the approved Site Plan for the proposed Resort and Casino. The project is now identified as Lago Resort and Casino. The Site Plan Modification includes an increase of the total footprint by 46,600 Sq. Ft. largely impacted by the increase of the area for the parking garage to offset the decrease of the number of stories of the garage structure (6 stories reduced to 4). The location of the Hotel on the property is changing and will result in an overall 14' total height reduction. A daycare facility has also been added.

Pine View Apartments
Route 414

This application is for a 48 apartment unit complex proposed for east of Route 414, south of Route 318. As there are many outstanding questions regarding this project and being the Town of Tyre Planning Board has not yet had the project presented at a meeting and Town Planning Board action would not be until after the September meeting of the County Planning Board, the Town Planning Board Chairman has consented to action on this matter being delayed until the September meeting of the County Planning Board if the County Planning Board wishes.

Cornerstone Mennonite School
4524 Route 96A

This application is for the conversion of a former gas station to a church owned school for 20-30 students. There are no significant changes to the outside footprint. Parking and mowed areas to remain unchanged. The students will be "car pooled" to the location.

This application is for a Minor Subdivision of a 3.6+ acre parcel to sell $\frac{3}{4}$ of an acre to an adjacent property owner.

Temporary Moratorium on Mineral Extraction Approvals
