Upon arrival dog was in store and had access to the kitchen.

Handwashing facilities inaccessible, improperly located, dirty, in disrepair, improper fixtures, soap, and single service towels or hand drying devices missing

Hand washing facility had a box on it rendering it useless. Sink looked as if it had not been used in some time
