sausage in walk in cooler at 75F had "just pulled from oven" according to food preparer. "They par cooked, will cook to temp later". CORRECTED: moved back to oven will heat to 165F; hold at 140F or cool from 120F-70F within 2 hours; 70-45F within 4 hours then reheat to 165F and then hold at 140F

IMPROPER CONSTRUCTION AND MAINTENANCE OF PHYSICAL FACILITIES.

ITEM # 15B WAS FOUND IN VIOLATION 1 TIME(S).

Code Requirements

Lighting and ventilation inadequate, fixtures not shielded, dirty ventilation hoods, ductwork, filters, exhaust fans

Hood needs cleaning
