Board Meeting  
Tuesday, July 12, 2016

Call to Order

Chairman Westfall called the meeting to order at 6:00 p.m.

Roll Call of Members by the Clerk

Ten members of the Board of Supervisors answered roll call. Sprvrs. Hayssen, Kaiser and Reynolds arrived after the roll call. Sprvr. Lazzaro was not present.

Pledge of Allegiance and Moment of Silence

After the moment of silence, Chairman Westfall called a recess of the board meeting, for the presentation of the Purple Heart award and to reconvene following the presentation.

Purple Heart Award

Tyler Simmons, who served as a corporal in the Marines, received the Purple Heart Award. Mr. Simmons was wounded when an improvised explosive device, detonated near a Humvee he was riding in as a machine gunner. Mr. Simmons thanked Seneca County Director of Veterans Affairs Jack O'Connors for arranging the medal presentation and with helping his transition back to civilian life since his December 2009 discharge.

New York Power Authority Energy Efficiency Program

Joseph A. Crimi, P.E., PMP, WNY Lead Program Engineer. NYPA is the largest state public power organization. It has been a delivery of energy services to New York State public entities and municipalities for over twenty-five years. The program offers lighting upgrades and lighting controls – indoor and outdoor; heating, ventilation and air conditioning (HVAC) improvement; high efficiency motors, motor controls, variable speed drives; Energy management / building management systems; renewable energy; and energy audits and feasibility studies.

Petitioners

Diane Potter, resident, Monroe County, presented to the Board of Supervisors her concerns regarding the proposed children daycare center for del Lago, located at the former Bonadent building on North Road.

Mark Benjamin, Community Relations Director, Seneca Meadows Landfill, addressed how Seneca Meadows was giving back to the community beyond the host agreements, citing scholarship awards to high school graduates pursuing studies in Environmental Science Conservation; as well as financial support for the Back Pack Program which provides weekend meals to kids during the school year. There will be an open house on August 21, 2016 of Seneca Meadows Landfill operation.

Kyle Black, District Manager, Seneca Meadows Landfill. Mr. Black addressed the economic impact assessment that was performed by CGR at the urging of local businesses that approached Seneca Meadows regarding how it would impact the community if it were to close. According to the assessment, the principal impact of closure would be lost revenue to Seneca Falls, resulting in more than double the property tax rates from \$5.24 per \$1000 of full value to about \$11.25 per \$1000 full value; and for Waterloo, by increasing the tax paid on the median value home by \$231. Taxes foregone by the closure will influence the property tax rate in other local governments, although by a smaller proportion. Seneca Meadow's share of the Seneca County tax levy is about 3%. Funds flowing from Seneca Meadows to the Waterloo Central School District total about 2% of the district's levy. The Seneca Falls Central School District would lose funds equivalent to about one half of one percent of its levy.

Reports of Standing Committees

The following reports are from the June 28 committee meetings.

Public Health Services – Sprvr. McGreevy, Chairman. Beginning this fall, South Central School will be offering on-site tuition based services such as Speech Therapy, Occupational Therapy and Physical Therapy for the preschool program. A resolution is on the agenda authorizing a contract with South Seneca School as required by the health department. The period covered with this contract is Sept 1 2016 through Dec 31, 2019.

NYS awarded Seneca County Health Department \$52,096 for the period July 1, 2016 through June 20, 2017 for the emergency Planning Grant. There is a resolution on the agenda which will authorize the signing of required documentation to receive this grant.

Public Safety – Sprvr. Davidson, Chairman. The committee approved refilling position as

recommended by the Vacancy Committee: Two (2) Corrections Officers for the Sheriff's Department; One (1) Investigator for the Sheriff's Department; and One (1) Nurse LPN for the Sheriff's Department.

The committee also briefly discussed complaints that because the county changed its radio frequency – the public is unable to hear police calls that come over their personal scanners. Before we look further into this, we will meet with our emergency management director and police chiefs.

Indian Affairs – Sprvr. Shipley, Chairman. Brian Laudadio, legal counsel with Bond, Schoeneck & King, will be at the July committee meetings to give us an update on the 2<sup>nd</sup> Circuit Court proceeding; and to inform the committee on a proposal offered by Cayuga Nation regarding tax payments.

Mental Health Services – Sprvr. Hayssen, Chairman. The committee approved recommendations offered by the vacancy committee to refill the coordinator position for Crime Victims, Witness and Domestic Violence, which was vacated due to retirement. The current Service Advocate will be promoted to that position. Since her position will be vacant due to the promotion, the committee approved refilling the position for Domestic Violence Services Advocate; and we approved the creation and filling of a full-time Nurse Practitioner position to address the primary health care for those suffering from mental illnesses and substance abuse. The position is 100% funded by the Finger Lakes Performing Provider System. The position will be filled in 2017.

The NYS Office of Mental Health Suicide Prevention Coalition awarded a grant in the amount of \$3,500. There is not county match for this grant.

Human Services – Sprvr. Hayssen, Vice-Chairman. The committee approved an agreement with Finger Lake Community College to offers classes in Seneca County at satellite locations. This is an annual agreement and allows FLCC to bring the classroom to the community, since their campus is in Canandaigua.

Two gentlemen will receive our endorsement for their appointment to the Finger Lakes Workforce Investment Board: Jerry Moran, Sr. VP of Human Resources for del Lago Resort and Casino; and Tom Albanese, Director of Human Resources for ITT/Goulds Pumps.

The 2016-2017 Supervision and Treatment Services for Juveniles Program (STSJP) Plan is due on August 1. The plan provides services to youth who are at risk. The anticipated funding for the program is capped at \$40,638 in state reimbursement.

Environmental Affairs – Sprvr. Churchill, Chairman. Five companies responded to the RFP for water testing. The bids have been made available to the supervisors for review. The issue will be on the July committee meeting agenda. County Manager recommended Alpha Analytical out of Massachusetts to test the water for one year for \$4,388.

Knauf Shaw will come to the July committee meeting to discuss if their services are needed. The resolution passed by the Board resolved to hire the firm to fight against bringing more garbage up from

New York City. Now that NYC will not be pursuing a contract with Seneca Meadows for their garbage, we want to meet with them to see if retaining their services will continue to be beneficial for the county.

Prior to tonight's board meeting, the committee met to reaffirm the county's position regarding the protection of Seneca Lake from LPG storage. The committee referred a resolution for consideration by the Board of Supervisors. It will be introduced under New Business.

Planning, Development, Agriculture & Tourism – Sprvr. Churchill, Chairman. The planning committee approved appointing David Fitzgerald, from the town of Fayette, to the Seneca County Planning Board as an At-Large member.

We discussed an agreement between Seneca County and the Finger Lakes Regional Land Bank Corporation (FLRLBC) for professional services in order to assist the land bank community development and revitalization activities. There is a grant award of \$150K to provide start-up funding for staff and administrative expenses associated with the operation of the Land Bank.

New York State Department of Transportation has awarded a grant to assist in the design and construction of a hangar at the Finger Lakes airport. The grant requires a local match of \$80K.

Finally, paperwork needs to be finalized to accept grant funding from the NYS Snowmobile Grant Program for the 2016-2017 winter season. Seneca County is the pass through agency, with agreements in place with Twin Lakes Snowmobile Association and Seneca Sledders Snowmobile Association.

Government Operations – Sprvr. Garlick Lorenzetti, Chairwoman. The committee discussed how we can publish the annual county directories more efficiently. The decision was made to continue with paper copies and updating the website copy throughout the year.

The November board meeting is scheduled for the same day as Election Day, which is a county Holiday. The general consensus is to move the meeting to the following date, November 9 at 6:00 p.m.

The county clerk's office has seen a large increase in land records recording and filing court cases. The Vacancy Committee recommended creating a position of a part-time clerk for that office.

Also on tonight's agenda is the Standard Work Day Resolution, which is a requirement by NYS; that elected officials who are in the retirement system are required to report their activity for three months and report it to the Comptroller's office.

Due to three of the four employees in the treasurer's office retiring, the committee approved paying Nick Sciotti a \$1,000 stipend, in addition to his current compensation, for each month of continued performance of additional duties beyond August 1, 2016; including training, personnel and transition management as well as other duties related to the reorganization of County Finance.

Public Works – Sprvr. Trout, Chairman. The committee approved creating a full-time Motor Equipment Operator (MEO) Light position to be shared between the Highway and the Water & Sewer

departments. The position will be effective in 2017. The committee also authorized refilling the position for a part-time Maintenance Worker and refilling the position for a part-time Cleaner, both for the LEC.

The Highway Department will be purchasing a 2016 John Deere 644K 4WD Wheel Loader for Highway Department, at a cost not to exceed \$204,220.51.

The New York State Department of Health has implemented new regulations requiring all cooling towers to be registered, tested, inspected and certified. The current contract with Waterwise needs to be amended to incorporate these services. The extra cost for the additional service is \$1,800 annually.

The County needs to develop a Solid Waste Management Plan. The county manager will solicit engineering services to prepare a plan for Seneca County.

The committee agreed with the county manager's recommendation to offer the bid for fleet management services to Enterprise. Several factors in Enterprises favor: Enterprise offers fuel management; no mileage restriction, a larger variety of models; to sell county vehicles at competitive prices and the money comes back to the county. There is a resolution on tonight's agenda authorizing an agreement with Enterprise Fleet Management, Inc.

Roy Gates, our Superintendent of Highways, reported that he met with the property owner on the west side of the corner of River Road and Kingdom Road. The owner agreed that the county can remove trees and fix the right of way for better visibility at that corner. As for concerns expressed by constituents regarding truck traffic on Packwood Road, Superintendent Gates will research the viability to limit vehicles with more than 10 ton MGWV, exempting local deliveries and pick-ups.

#### Chairman's Remarks

Chairman Westfall said it has been a disturbing month with the recent attacks on police officers nationwide. He was referring to recent incidents in the news of police officers being shot allegedly in response to news reports of unjustified shootings by police of black men in Louisiana and Minnesota. The worst attack occurred earlier this month in Dallas, Texas where five police officers were killed, and several other incidents have been reported nationwide of similar attacks against police officers.

Chairman Westfall expressed his gratitude for the Seneca County Sheriff's office and local police departments and the officers who serve our community.

#### County Manager's Remarks

County Manager Sheppard said there was a water main break at the Law Enforcement Center. He recognized the Sheriff's Office, the Village of Waterloo and the County Facilities Department for the swift response to fixing the situation. Additionally, regarding the recent dry weather with drought conditions, County Manager Sheppard empathized with our local farmers who are experiencing a difficult season.

WHEREAS, the Seneca County Highway Superintendent has evaluated staffing needs for the Highway Department and the Water & Sewer Department and determined it would be beneficial to create one full-time position of MEO Light to be shared with the County Highway Department and the County Water and Sewer Department; and

WHEREAS, the position will be at Grade 4 of the CSEA Salary Schedule; and

WHEREAS, the position will be effective January 1, 2017; and

WHEREAS, the creation of said position was approved by the Vacancy Committee on June 16, 2016 and the Public Works Committee on June 28; now therefore be it

RESOLVED, that the Seneca County Board of Supervisors does hereby authorize the creation of one (1) Full-time MEO-Light position at Grade4 of the CSEA Salary Schedule beginning January 1, 2017 with duties of said position to be shared between the County Highway Department and the County Water and Sewer Department.

WHEREAS, the Seneca County Highway has three (3) quotes for a 2016 Wheel Loader from Monroe Tractor, Vantage Equipment and Five Star Equipment(John Deere); and

WHEREAS, the Seneca County Highway Department is requesting to buy a 2016 John Deere 644K 4WD Wheel Loader from Five Star Equipment; and

WHEREAS, funds for the purchase of one (1) 2016 John Deere 644K 4WD Wheel Loader, OGS bid in the amount of \$204,220.51 have been appropriated from the 2016 Seneca County Highway Road Machinery Vehicle Account 50-120-5-5130.2600; and

WHEREAS, the purchase was approved by the Public Works Committee of the Seneca County Board of Supervisors on June 28, 2016; now, therefore be it

RESOLUTION NO. 149-16, moved by Supervisor Trout, second by Supervisor Wadhams and adopted.

WHEREAS, the New York State Department of Health has implemented regulations that require the registration, testing, inspection and certification of cooling towers; and

WHEREAS, our existing contract with Waterwise, Inc., 75 Bernar Park, Suite 5, Rochester, NY 14624, does not meet the regulations set forth by NYSDOH; and

WHEREAS, Waterwise, Inc. offers a comfort cooling/seasonal plan that meets the NYSDOH requirements at an annual cost of \$1,800.00 to treat the cooling tower located at 48 W. Williams St., Waterloo, NY; and

WHEREAS, a transfer from the Contingency Fund is needed as the funds for this cost are not appropriated in the 2016 Seneca County adopted budget; and

WHEREAS, The Public Works Committee approved the County Manager to sign a (1) one year Preventative Maintenance Agreement with Waterwise to service the cooling tower meeting the New York State Department of Health requirements at its committee meeting on June 28, 2016; now, therefore be it

RESOLVED, that the Seneca County Board of Supervisors authorizes the County Manager to sign a contract with Waterwise; and be it further

RESOLVED, that the Seneca County Board of Supervisors authorizes and directs the Seneca County Treasurer to make the following transfer:

Prior to the adoption of Resolution No. 149-16, Sprvr. Shipley said he would be voting against the resolution because the regulations that require registration testing, inspection and certification of cooling towers is another New York State unfunded mandate.

Motion to Accept Bid for Fleet Management

Sprvr. Trout offered a motion to award the bid for fleet management services to Enterprise Fleet Management, Inc. Sprvr. Davidson seconded the motion.

Sprvr. Hayssen offered a motion to the main motion to lay the motion on the table until Finger Lakes Chrysler could make a presentation to the Board of Supervisors. Sprvr. Churchill seconded the

motion.

Debate

Sprvr. Hayssen brought forth his concern that Finger Lakes Chrysler, who was one of the two companies that were considered for fleet management services, is a local company, and Enterprise is a national company. Finger Lakes Chrysler is moving its business on Route 414 in the Town of Tyre. They employ local people. He said the Board of Supervisors saw a presentation by Enterprise, and questioned why Finger Lakes Chrysler wasn't asked to make a presentation.

Sprvr. Kaiser added that he didn't realize any other company was being considered other than Enterprise.

Sprvr. Trout said he has met with both representatives from both companies. He said each company offered different options for fleet management services. It wasn't reasonable to expect the options could be compared side by side – it is like comparing apples and oranges.

County Manager Sheppard said he stood by his recommendation to contract with Enterprise Fleet Management, Inc. Benefits offered by Enterprise include a nationwide market for resale of our vehicles; the lease option will save \$400K in ten years; and vehicle maintenance will continue to be serviced by local auto shops.

Vote

Chairman Westfall called for a vote on the motion to the main motion to table the motion until Finger Lakes Chrysler could make their presentation to the Board of Supervisors. The motion was failed by 364 ayes (Hayssen, Reynolds, Wadhams, Prouty, Kaiser, Churchill, Kronenwetter), 318 nays (Davidson, Garlick Lorenzetti, McGreevy, Westfall, Shipley, Trout) and 68 not present (Lazzaro).

Chairman Westfall called for a vote on the main motion. The motion failed by 318 ayes (Trout, Davidson, Garlick Lorenzetti, McGreevy, Westfall, Shipley), 364 nays (Hayssen, Reynolds, Wadhams, Prouty, Kaiser, Churchill, Kronenwetter) and 68 not present (Lazzaro).

WHEREAS, this grant allows for state support to counties for eligible public safety call-taking and dispatching expenses; and

WHEREAS, the state support is in the form of reimbursement for operating expenses to the PSAP, including personal services; and

WHEREAS, the enacted state budget for 2016 - 2017 appropriates \$10 million for all those eligible (62 counties); and

WHEREAS, the Public Safety Answering Points Operations Grant is non-competitive and will allocate money by a formula which equitably distributes funding among counties based on quantifiable elements and relevant metrics with no local match; and

WHEREAS, Seneca County is seeking \$217,572 to pay for a one year radio maintenance service agreement through Motorola Solutions; and

WHEREAS, the application deadline for the grant is August 4, 2016; and

RESOLVED, the Board of Supervisors approves applying for the 2016 - 2017 Public Safety Answering Point Operations Grant and authorizes the County Manager to sign all paper work related to the same.

#### Rule 29

Sprvr. Trout moved the following resolution to the floor in accordance with Rule of Order No. 29.

**BOARD OF SUPERVISORS AUTHORIZE THE PURCHASE OF REAL PROPERTY TO ACCOMMODATE THE NEAR FUTURE SALE OF THE COUNTY HEALTH BUILDING**  
RESOLUTION NO. 169-16, moved by Supervisor Trout, second by Supervisor Garlick Lorenzetti and adopted.

WHEREAS, Board of Supervisors resolutions, 42-08, 100-10 and 120-16 identify inadequacies of the Health Building or an opportunity to purchase replacement space at both a fiscal advantage and an enhancement of municipal services; and

WHEREAS, the county health building, nearly 16,000 sq-ft, is no longer an appropriate space for any municipal services and would require an inordinate effort of time and money to remain in service, and

WHEREAS, del Lago Casino has a NYS Gaming Commission obligation to provide child care services as a condition of their resort and casino operations; and

WHEREAS, the former BonaDent building, at 2465 North Road, Seneca Falls is available and capable of replacing the office space of the county health building once vacated; and

WHEREAS, the former BonaDent building's original design and function included a child care facility which is currently in near "move in" condition; and

WHEREAS, the location of the building is in close proximity to the government office building, is within a few miles of the del Lago Casino and can fulfill del Lago's child care requirement in addition to enhancing the child care capability county-wide; and

WHEREAS, lease revenue from tenant organizations occupying space in excess of County requirements will offset utility expenses and building maintenance requirements; and

WHEREAS, the County is in need of a "Facilities Master Plan" (FMP) to; best analyze the use of existing office space relative to departmental function, make recommendations for realigning departments to future spaces, prioritize on reducing administrative effort and expenses while maintaining or enhancing services; and

WHEREAS, the FMP will identify the proper sequence over time to refurbish existing spaces, occupying new spaces and, based on departmental functions, prioritize on; consolidation, efficiencies, location, synergies and an archiving capability; and

WHEREAS, this resolution was brought to the floor by a 2/3 majority of the Board of Supervisors under the Rule 29 Rules of Order of the Seneca County Board of Supervisors; now therefore be it

RESOLVED, that the Board of Supervisors authorizes the establishment of capital improvement plan, CP01-16 to purchase replacement office space in anticipation of vacating and selling the County health building and originating a professional Facilities Master Plan (FMP); and be it further

RESOLVED, that the County Treasurer is authorized to restrict both \$2,500,000.00 of Casino Gaming Application funds and \$1,000,000.00 Cayuga Nation property tax reparations funds for the funding of CP01-16; and be it further

RESOLVED, that the Board of Supervisors directs and authorizes the County Manager, in cooperation with the County Attorney, to sign documents relative to the purchase and transitional occupancy of the former BonaDent building at a purchase price not to exceed \$3.2M; and

RESOLVED, that any costs of materials, exceeding \$600,000.00 for the reorientation of the former BonaDent building for use by the County, will be borne by the County; and

RESOLVED, that the Board of Supervisors directs and authorizes the County Manager, in cooperation with the County Attorney, to sublet office space in the name of the County, to del Lago Casino and Resorts for child care services and initial cadre training in good faith and at the market price; and further be it

RESOLVED, that the Board of Supervisors directs and authorizes the County Manger to author and distribute a Request for Proposal seeking professional bids to fulfill the county need of a FMP.

Prior to the adoption of Resolution No. 169-12, Sprvr. Hayssen asked if there were any concerns regarding a daycare in the same location as a mental health clinic. County Manager Sheppard said that the daycare facility will be dependent on New York State licensing. If the license is denied or the Board of Supervisors prefers not to locate the mental health clinic at Bonadent, there may be other departments that could be moved over there. The Thurber Drive building would be too costly to renovate, but mental health could be moved to the county building, and other departments could be moved to Bonadent.

Rule 29

Sprvr. Trout moved the following resolution to the floor in accordance with Rule of Order No. 29.

DEVELOPMENT (ESD) INCENTIVE PROPOSAL**

RESOLUTION NO. 170-16, moved by Supervisor Davidson, second by Supervisor Garlick Lorenzetti and adopted.

WHEREAS, Resolution 131-16 establishes the Seneca County Route 318 Corridor Sewer Improvement District; and

WHEREAS, New York State Empire State Development (ESD) has offered Seneca County an Incentive Proposal for the 318 sewer project; and

WHEREAS, this proposal includes a Regional Council Capital Fund Capital Grant in the amount of \$1,500,000.00 for reimbursement for a portion of the construction costs for sewer on NYS Route 318; and

WHEREAS, the application fee is \$250.00 and the funds are available in the 2016 adopted budget 108020-54371; and

WHEREAS, the deadline for the application is August 10, 2016; and

WHEREAS, this resolution was brought to the floor by Rule 29 of the Rules of Order of the Seneca County Board of Supervisors; now, therefore be it

RESOLVED, that the Seneca County Board of Supervisors authorizes payment of the \$250.00 application fee from account 108020-54371; and be it further

RESOLVED that the Chairman of the Seneca County Board of Supervisors be and hereby is authorized to sign all documents relating to the application for the incentive proposal in the amount of \$1,500,000.00 for reimbursement for a portion of the construction costs for sewer on NYS Route 318.

Prior to the adoption of Resolution No. 170-16, Sprvr. Wadhams stated he would be voting against the resolution. He objected because it would benefit the County if they had met with the staff from the Town of Junius. Junius has a water treatment plant that will most likely become defunct when



the outlet mall connects to the Route 318 sewer line.
