**EXTEND CONTRACT FOR THE SECOND RENEWAL YEAR WITH  
WECARE FOR RECYCLING PICKUP**

RESOLUTION NO. 147-14, moved by Mr. Kaiser, second by Mr. Davidson and adopted.

WHEREAS, the initial three year contract with WeCare Recycling expired on October 31, 2013;  
and

WHEREAS, there are two renewal options for one year at the sole discretion of Seneca County in the contract; and

WHEREAS, WeCare has done a very good job providing curbside recycling pickup to the residents of Seneca County; and

WHEREAS, the first renewal year which was adopted by the Board of Supervisors in 2013 for curbside pickup will expire on October 31, 2014; and

WHEREAS, it would be in the best interest of Seneca County to extend the second renewal year to provide recycling pickup in Seneca County; and

WHEREAS, the Seneca County Board of Supervisors Standing Committee for Public Works approved this resolution at its meeting on June 24, 2014; now, therefore be it

RESOLVED, that the Board of Supervisors extends the second renewal year to WeCare for recycling pickup in Seneca County at a contract cost of \$440,998 (\$21,000 increase) for the term November 1, 2014 through October 31, 2015.

**SENECA COUNTY RECEIVES \$1.1 MILLION FOR BRIDGE MAINTENANCE (amended)**

RESOLUTION NO. 148-14, moved by Mr. Kaiser, second by Mr. Shipley and adopted.

WHEREAS, Seneca County has been awarded \$1.1 million for bridge maintenance; and

WHEREAS, the purpose of the monies is to do maintenance repair on seven County bridges; and

WHEREAS, the project will start in 2014 and construction will start in 2015/2016; and

WHEREAS, the County's cost will not exceed 20% to be funded thru the CHIPS program account number 405112-52000; and

WHEREAS, the Board of Supervisors Standing Committee for Public Works approved this resolution at its meeting on June 24, 2014; now, therefore be it

RESOLVED, that the Seneca County Board of Supervisors accepts the \$1.1 million from New York State to do maintenance on seven bridges.

**SUPERVISORS AWARD BID FOR STRIPING OF COUNTY HIGHWAY**

RESOLUTION NO. 149-14, moved by Mr. Kaiser, second by Mr. McGreevy and adopted.

WHEREAS, on March 10, 2014 Seneca County solicited bids on a contract for the painting of traffic lines on Seneca County highways; and

WHEREAS, the two bids received were opened on April 24, 2014 and were from Seneca Pavement Marking of Horseheads, New York and Accent Stripe, Inc. of Orchard Park, New York; and

WHEREAS, the lowest bid was from Seneca Pavement Marking; and

WHEREAS, the Public Works Committee of the Seneca County Board of Supervisors recommended accepting the bid from Seneca Pavement Marking on June 24, 2014; now, therefore be it

WHEREAS, in Seneca County, all emergency calls as well as all other calls for service for Law Enforcement, Fire, Ambulance and any other Emergency Services, are channeled thru the E911 system and handled by the E911 dispatchers. The present system, CAD (Computer Aided Dispatch) will be defunct in 2016. Currently, each agency (i.e. police departments, fire departments, ambulance corps.) work on their own independent software. The present software used by the Waterloo Police Department, the Seneca Falls Town Police Department, the Interlaken Police Department and the Seneca County Sheriff's Office is the Spectrum Justice System (SJS), which was defunct some years ago. All the different software and operating systems aren't able to integrate and communicate effectively between different agencies; and

WHEREAS, a project committee, formed with members of the Seneca County E911 Advisory Board which included representatives from Seneca County E911, Emergency Services, the Sheriff's Office, Seneca Falls, Waterloo and Interlaken police departments. For the past year, this committee has considered five different vendors. The committee selected Spillman Technologies, Inc. as the choice vendors based on many issues such as: One Site License; Next Generation 911; onsite training to all users, not just selected trainers; Systems in 38 states which includes five counties within New York State; GPS Mapping which becomes the backbone of the system bringing hundreds of maps within the county into one mapping system available to all; 30 year company history which has put out 20 upgrades to its system throughout the years showing that this is not a system that will need to be replaced in seven to ten years; a ten year pre-paid maintenance program that can save the county over \$300,000 in fees; and

WHEREAS, a demonstration was provided to the Public Safety Committee on June 19, 2014 at the LEC by Spillman Technologies as well as a short presentation at the beginning of the BOS Committee meeting on June 24, 2014, with questions fielded at each meeting; and

WHEREAS, the Public Safety Committee passed a motion at the June 19, 2014 Public Safety Committee meeting to recommend to the full Board of Supervisors to hire Spillman Technologies, Inc. as the vendor for the upgrading of the county's public safety software and CAD in the amount of \$1,310,287; and

WHEREAS, financing for this program will initially come from County Reserve Fund with an application to Homeland Security for an amount that equals total cost and in the circumstance that the grant application is unsuccessful then bonding for the project would be sought; and, be it

RESOLVED, that the Board of Supervisors approves the purchase of Spillman Technologies, Inc. CAD (Computer Assisted Dispatch) for a sum of \$1,310,287, financing provided thru the County Reserve Fund with reimbursement to follow either thru a Homeland Security Grant or Project bonding; and be it further

RESOLVED, that the Chairman of the Board is authorized and directed to sign a contract with Spillman Technologies, Inc. consistent with this resolution.

**BOARD OF SUPERVISORS APPOINTS ELECTION COMMISSIONER

Addressing the Seneca County Board of Supervisors July 8, 2014

Good evening. Thank you for the opportunity to address the full Seneca County Board of Supervisors tonight. I come here this evening to question why the Planning Board Committee recommended Colby O'Brien for the alternate seat that I have held for the last year on the Seneca County Planning Board. In fact, it was just last year that the entire Board voted me in for this position, congratulated me, and thought I was a very good fit. Many people are having a hard time understanding this move to now replace me...especially myself.

Over the last year on this board I missed only one meeting due to rotator cuff surgery. I have faithfully showed up to the meetings and participated in the alternate committee member capacity. I have asked many questions along the way, trying to learn as much about the process as I can, learn the lingo per se, how things fit together, attended more training sessions than state mandated, and tried to make good decisions on projects that have come before the planning board. I question projects to get a better understanding of how a project will affect our County and its residents, and usually more information is needed to feel a project would be a good fit.

I have loved this community that I call home since moving here in 1976 and building my solar/energy-efficient home and my life here in Seneca County. I have opened my home for tours to show my fellow community members that thinking outside the box and having the goal of working for sustainability is good for us all. Yes, I have ALWAYS questioned things as you all well know from all the years I've spent attending County Board meetings, town board meetings, etc. I always have and I always will. It is obvious to anyone who knows me I think outside the box most of the time and to do that is important; we all need to think outside the box from time to time for future growth and it's important to do this on a county, town, and personal level. But, when I have questioned how things operate, I have ALWAYS had suggestions on what could make things more efficient in all ways, and have tried to work with all facets of our town and county governments to move our county forward on a path of sustainability that will profit all, not just a few.

Along the way I have been involved in many projects in our county. As a county resident we have the responsibility to step up, get involved, and help make our community the best it can be. These are things that have been part of my life, and I have tried to be a good role model for children as well as other community members. Almost 10 years ago I was instrumental in getting the Little League fields switched from the landfill site over to the high school fields and the bus garage and salt barn over to the landfill property given to the Little League. It was good and smart planning. This is what I stand for- children should be kept safe at all costs as they are our future in our county. This smart planning also stopped urban sprawl as a traffic light is no longer needed on the North Road and our school children do not have to breathe additional bus fumes at our school. I also look at trying to bring good, sustainable jobs to our community so our children will come back after college to live, work here, pay taxes, and raise their families in Seneca County. We need job diversity in our county instead of letting our children



move to other areas for their needs. We need to ask questions and find out why our county is not prospering in this capacity and make the necessary changes to change this.

I have spent countless dollars of my own money and my time doing educational programs around the county, especially regarding environmental issues. In fact, I came before the board several years ago with my composter, recycling quiz, recycled money pencils, reusable bags, etc. asking you to include funding in the county budget for environmental education that is so important for our continued growth so community members will have the knowledge to save resources in our county. Again, this would not have happened if I did not ask.

I've worked with school groups, Girl scouts, Boy scouts, and the community at-large over the years trying to educate about environmental issues. This is where my degrees in Natural Resources Conservation and Environmental Science and also, my training come in. I love the environment and I chose to move to Seneca County because of the natural resources that abound in our area. I don't know of anyone else on the County Planning Board that brings to the table the environmental slant on issues, and let's face it, most of these projects do indeed affect the environment in our community in one way or the other.

In the past we only had basic information regarding the project before the meeting of the County Planning Board. It was my suggestion to the board about adding a synopsis of the projects that will be on the upcoming agenda so if people wanted to know more about a project before the actual meeting, they could investigate further. This new feature is very helpful when we get the agenda a week before the meeting. I know it helps me think of questions that should be asked but without having the time to actually read the review of the project, look at accompanying maps, etc. at the meeting, it is difficult.

I have also questioned the time line for having to vote yes or no on a project. It seems that 10-20 minutes before the planning board is not enough time to thoroughly go over projects such as the proposed Seneca Meadows rail yard to make a decision of such importance that will definitely change the face of Seneca County. Larger projects before the board need more than 10-20 minutes of discussion before being voted on. There are many details that we should know about before voting a project in and more time is a necessity for good decisions affecting all of us. I have asked valid questions, especially on large projects. Some questions go unanswered and yet we have to make a decision on the spot. According to municipal law the county can ask for an extension to review a project from the town of origin. That has not happened in the time I have sat on this board.

I have also brought up to the planning board we should make decisions on projects that are simple subdivisions or other similar types of projects instead of sending them back to the towns of origin to make the decision on their own. I mentioned that these towns have spent the time to send these projects to us for decisions-even though we are considered an advisory board-and to send the project back to them asking them to make the decision without our input, does not encourage partnership with the towns that look to the county for their blessing. A simple yes or no would go a long way with

encouraging towns and the county to work together. This did take place at the last board meeting. Again, this would not have happened without asking for it.

As a new member of the planning board I have been trying to bring fresh ideas and viewpoints to the planning board and not just pass projects along. Perhaps this is not how it has been done in the past, but we need change and new ideas to grow our county and I don't know how else to bring that change about.

I also found out 5 years have passed and there still is not a viable County Comprehensive, Environmental, Solid Waste, or Economic plan for Seneca County. I brought this oversight up, especially when large projects that would no doubt change the face of Seneca County were under scrutiny many times. I also brought it up with you all here tonight. If you remember, I gave each of you a copy of my speech and expressed how difficult it is for a planning board to make intelligent, good decisions on which way we want our County to grow without having these valuable documents.

I believe my education and years of community participation and experience make me the most qualified person for this position and experience and training do count. Please take a look at Mr. O'Brien's qualifications and then vote for who would be a better fit for the alternate position on the Seneca County Planning Board.

I will accept the outcome of your vote tonight but hope you look at my qualifications to sit on this board and return me to the County Planning Board. I take being an alternate on this board seriously as the board cannot do its business without alternates when regular members are not in attendance. I understand you are working for the good of the county and I respect that. But ask yourself this question...will forcing me off the county planning board be a good thing for the community? I see Mr. O'Brien has inserted himself on quite a few boards recently and is also going to college. Who will dedicate more time to the County Planning Board?

Thank you for the time to address you all here tonight. I await the outcome of your vote. I sincerely enlist your support of my position as alternate on the Seneca County Planning Board.
