Call To Order

The meeting was called to order at 6:00 p.m. by Chairman Earle.

Roll Call of Members by the Clerk

All fourteen members of the Board of Supervisors answered roll call.

**2015 WORKFORCE DEVELOPMENT YOUTH BUREAU/BOARD'S

RESOLUTION NO. 137-15 moved by Mr. Lazzaro, second by Mr. Churchill and adopted.

WHEREAS, the Brightest Star Award recognizes one female and one male 6th grade student in Seneca County; and

WHEREAS, nominations are received from school personnel, and other youth serving agencies; and

WHEREAS, students were nominated and chosen for consistently reflecting the 5 Points of Light: Academics, Involvement in School or Community Activities, Responsibility, Respect, and Compassion; and

Petitioners

Stephanie Engster, Labor Relations Specialist for the Civil Service Employees Association (CSEA), addressed the board with multiple concerns affecting caseworkers in the departments of Foster Care, Preventive, Child Protective and Adult Protective Services. The concerns include the safety of the caseworkers when they go on home visits, the many hours required to work outside the regular workday, and the salaries which are below the average rate of pay.

Several CSEA employees were present and addressed the Board of Supervisors. A report was distributed showing a direct correlation between poor retention of staff and Seneca County's non-competitive pay and benefits schedules for employees in the cited department. A copy of the report is attached for the record.

In response to the concerns presented, Supervisor Lazzaro, Chairman of the Human Services Committee, stated that his committee would review the concerns and that it would be on his agenda for the July committee meeting to consider the current job classification for the caseworkers in the departments.

#### Submission of Claims for Audit

Supervisor Prouty made a motion, seconded by Supervisor McGreevy, to approve the following vouchers for payment in accordance with the county auditing process. The motion passed with a nay vote by Supervisor Hayssen, who objected because the Claims for Audit includes bills submitted by Mary Anne Kowalski for her services as Interim Administrator and the bills lack itemization and detail.

Supervisor Hayssen also suggested the claim audits for the Water & Sewer Department be paid from the contingency fund and then reimbursed by the department, because the bills appear to be divided equally between the three districts (Water 1, Sewer 1, and Sewer 2). Supervisor Hayssen said that funds should be allotted fairly as the districts serve the users and funded by the users.

#### Reports of Standing Committees

Public Health Services Committee – Supervisor McGreevy, Chairman. At its meeting on June 23, the Committee voted in favor of the following issues and referred them to the Board of Supervisors: A contract with Cathy Bond as a consultant, funded through the Public Health Emergency Preparedness Grant for \$3,300 per month not to exceed \$39,600 for the period of July 1, 2015 – June 30, 2016; the appointment of Dr. Scott Kolsin as a member of the Seneca County Board of Health for a six-year term from January 1, 2015 – December 31, 2020; authorize the Chairman of the Board to sign necessary documents to accept grant funding in the amount of \$92,849 for the period of April 1, 2015 – March 31, 2016 from NYS Department of Health for the Water Enhancement Grant; the reappointment of Vickie Swinehart, R.N. for Director of Public Health for a six-year term to expire on July 6, 2021; and the creation of a new position for Senior Public Health Educator due to additional responsibilities in working with the S2AY Rural Health Network to achieve and maintain quality assurance and national accreditation status.

Supervisor Garlick Lorenzetti asked about a complaint received by the Codes Enforcement Department regarding a condemned property after a fire destroyed the property on May 11 and a foul odor from the property. The odor was from food left in a freezer. The property owner was required to clear the property within 30 days of the fire. To the best of knowledge by the county codes department,

the freezer was removed from the premises and the lawn was mowed. The case was handled by another codes department that oversees where the property is located.

Human Services Committee – Supervisor Lazzaro, Chairman. The Committee approved the following items at its June 23 meeting: a resolution honoring the recipients of the Brightest Star Recognition award, Camden White, Seneca Falls Central School District and Daniel Cornelius, Romulus Central School District; approved a contract with Binnacle Technology Solutions, LLC for the provision of a Windows-based software to manage client accounts, maintain records needed for Social Security Representative Annual Reports and create the annual report at a cost not to \$20,000; and the (re)appointments of several members to the Finger Lakes Workforce Investment Board.

Planning, Development, Agriculture & Tourism – Supervisor Hayssen, Chairman. On June 23 the Committee met and approved several items to be referred to the Board of Supervisors for consideration. A contract with Barton & Loguidice for engineering services for the Route 318 sewer project was approved. The cost will be secured through funding by the NYS Empire Development Corporation for \$158,000 was approved; authorization for the chairman of the Board of Supervisors to sign required documents to extend a grant contract for \$7,000 for the Papa Bear Building renovations in Ovid, NY; and approval by the Committee to authorize a letter in support of the National Women's Hall of Fame application for Consolidated Funding.

Committee chair Hayssen also requested and received, approval by the Committee for a resolution by the Board of Supervisors asking our state representative to introduce a bill that will outlaw the killing of white deer in Seneca County and ALL of New York State.

Public Safety Committee – Supervisor Kaiser, Chairman. The Committee met on June 23 and addressed the concern regarding residents wandering off the Hillside Campus unattended by staff. Specifically a recent incident when a female resident was observed on camera vandalizing the property at The Kountry Stop in Fayette, NY. Hillside staff who were present at the scene, sat inside a vehicle watching the female resident. The Sheriff was contacted. Hillside policy does not allow forced physical intervention when a resident leaves the Hillside campus. They are limited to requesting the resident return to the campus of their own volition. The Sheriff stated that a meeting is scheduled with his office and Hillside to discuss alternatives when a resident leaves the campus.

Supervisor Garlick Lorenzetti said when this issue came up before, put in place was an 'email / text / call blast' that was sent to the community so they were aware that a resident had gone off the Hillside campus. It is reported that for this specific incident the community was not alerted by the blast. Supervisor Garlick Lorenzetti also stated that the cost of repairs to the Kountry Stop has been reimbursed by Hillside. She requested that the phone blast be reinitiated and that reimbursement be done in a timely manner.

The Committee also approved acceptance of a Homeland Security Regional HazMat FY15 Grant in the amount of \$110,000; and approved the introduction of proposed Local Law E of 2015 entitled "A Local Law to Establish Residency Requirements for the Position of Director of E-911 for Seneca County".

Mental Health Services Committee – Supervisor Serven, Chairman. At its meeting on June 23, the Committee voted in favor to refill two positions in the Mental Health department: one Senior Psychiatric Social Worker which was vacated due to a resignation and one Psychiatric Social Worker as the individual currently holding this position will be promoted to the Senior Psychiatric Social Worker position.

Finance, Assessment & Insurance Committee - Supervisor Prouty, Chairman. On June 23 the Committee met with Charles Bosman, member of the Town Board of Covert, who was seeking distribution directly to the towns, the County share of sales tax revenue beginning in 2016.

The Committee expressed opposition to Mr. Bosman's request because the state allows the counties to charge up to a 4 percent sales tax to help pay for state-imposed mandates and costs on the counties. The planned sales tax benefits the whole county equally by reducing their county taxes. The county provides the majority of services, compared to the towns and villages. No action was taken by the Committee.

**RESOLUTION TO SEND REQUEST FOR PROPOSALS FOR  
PERFORMANCE CONTRACTING AGENTS**

RESOLUTION NO. 139-15 moved by Mr. Westfall, second by Mr. Lazzaro and adopted.

WHEREAS, the Public Works Committee met with a performance consulting agent and discussed options to have some of the energy based equipment in our facilities to be upgraded; and

WHEREAS, the Public Works Committee agreed that these upgrades are needed due to the life of the equipment is past its efficiency capabilities; and

WHEREAS, the Public Works Committee agreed that Performance Contracting may be a good alternative to rectify some of our energy deficiencies; now therefore be it

RESOLVED, that the Seneca County Board of Supervisors does hereby authorize the Superintendent of Facilities and the Seneca County grant writer to send out a Request for Proposals for Performance Contracting Agents.

**BOARD OF SUPERVISORS AUTHORIZES CONTRACT WITH THE VILLAGE OF  
WATERLOO TO PROVIDE OPERATING SUPPORT AND ASSISTANCE TO SENECA  
COUNTY WATER AND SEWER DISTRICTS**

RESOLUTION NO. 140-15 moved by Mr. Westfall, second by Mr. Kubasik and adopted.

WHEREAS, Seneca County Public Works requires services to support the water and sewer operator and public works personnel in activities including the construction, operation, maintenance and repair of municipal water distribution and wastewater collection systems; and

WHEREAS, the Administrator of the County Water and Sewer Districts issued a request for proposals to provide these services and the closing date for proposals was June 30, 2015; and

WHEREAS, the Village of Waterloo and the Village Water District was the only entity to submit a proposal; and

WHEREAS, the proposal submitted met the needs of the Districts for services including but not limited to:

- Assist the Operator to obtain the appropriate certificates to perform all the required activities;
- Conduct the seasonal re-chlorination program at the Hillside tank;
- Provide assistance with the installation, extension, repairs, replacement and maintenance of water distribution and wastewater collection lines, as requested;
- Monitor the operation of the water distribution system on SCADA or through on-site inspections;
- Respond to leaks and other emergencies that cannot be handled by County personnel;
- Provide coverage for certified operators and other personnel during vacation and other authorized absence; and

WHEREAS, the rates for these services will be:

- Between the hours of 7am and 3pm on all days except Saturdays, Sundays, and Holidays, \$30 per man hour or any fraction thereof, portal to portal from and to Waterloo DPW Building,
- All other times, \$40 per man hour, time to be defined as above, with a 2 hour minimum
- Any time, \$50 per hour for each piece of equipment, without operator cost, time to be defined as above
- All supplies at actual cost; and

WHEREAS, the rates for these services will be reviewed annually; and

WHEREAS, this resolution has been approved by the Public Works Committee on July 9, 2015; now, therefore be it

RESOLVED, that the Chairman of the Board of Supervisors is authorized and directed to enter into an agreement with the Village of Waterloo and the Village of Waterloo Water District to provide such assistance as may be warranted, for the operation and maintenance of the County Water and Sewer Districts, until those services are no longer required to meet Health Department requirements.

**AUTHORIZE ACCEPTANCE OF THE  
HOMELAND SECURITY REGIONAL HAZMAT GRANT FY15**

RESOLUTION NO. 141-15 moved by Mr. Kaiser, second by Mr. Davidson and adopted.

WHEREAS, the Seneca County Office of Emergency Services has been awarded a FY15 State Homeland Security Regional Hazardous Materials Grant; and

WHEREAS, the grant award is \$110,000 (with no local match), and must be used for the sustainment of existing equipment and for the purchase of equipment for the four county Regional HazMat Team (Seneca, Ontario, Yates & Wayne); and

WHEREAS, the Public Safety Committee approved the grant at its meeting on June 23, 2015;  
now, therefore be it

RESOLVED, the Seneca County Board of Supervisors approves the acceptance of this grant and authorizes the Chairman of the Board of Supervisors to e-sign all grant paperwork; and be it further

**A RESOLUTION TO INTRODUCE PROPOSED LOCAL LAW E OF 2015 ESTABLISHING  
RESIDENCY REQUIREMENTS FOR THE POSITION OF DIRECTOR OF E-911 FOR  
SENECA COUNTY AND PROVIDING FOR PUBLIC HEARING**

RESOLUTION NO. 142-15 moved by Mr. Kaiser, second by Mr. Davidson and adopted by 693 ayes and 57 nays (Shipley).

WHEREAS, Section 3 of the New York State Public Officers Law establishes residency requirements for certain public officers; and

WHEREAS, exceptions to §3 P.O.L. have been passed rendering that law a special rather than general law and permitting municipalities to similarly create exceptions pursuant to New York State Municipal Home Rule Law, and

WHEREAS, it is the recommendation of the Public Safety Committee that a Local Law be enacted exempting from the residency requirements of §3 P.O.L., Seneca County's Director of E-911;  
now, therefore, be it

RESOLVED that proposed Local Law E of 2015 entitled "A Local Law to Establish Residency Requirements for the Position of Director of E-911 for Seneca County" be and the same is hereby introduced before the Board of Supervisors of Seneca County, New York to read in substantially the following form:

SECTION 1 The provisions of §3 New York State Public Officers Law requiring a person to be a resident of the political subdivision or municipal corporation of the state for which he or she shall be chosen or within which his or her official functions are required to be exercised, shall not prevent a person from holding the office of Director of E-911 for the County of Seneca, provided that such person resides in Seneca County or in an adjoining county within the state of New York;

SECTION 2 This local law shall take effect immediately upon filing with the Secretary of State in accordance with §27 of the Municipal Home Rule Law.

And be it Further

RESOLVED, that copies of the aforesaid proposed local law be laid upon the desks of each member of the County Board; and, be it further

RESOLVED, that the County Board hold a public hearing on said proposed Local Law at the County Office Building, 1 DiPronio Drive, Waterloo New York at or about 6:00 P.M., on August 11, 2015; and, be it further

RESOLVED, that the Clerk to the Board publish or cause to be published a notice of said public hearing in the official newspapers of the County at least ten (10) days prior thereto.

**RESOLUTION AUTHORIZING APPROVAL OF CONTRACT WITH BARTON & LOGUIDICE  
FOR ENGINEERING SERVICES FOR THE ROUTE 318 SEWER PROJECT**

RESOLUTION NO. 143-15 moved by Mr. Hayssen, second by Mr. Shipley and adopted.

WHEREAS, Seneca County solicited proposals from qualified firms to provide engineering services for the Route 318 Sewer Project; and

WHEREAS, Barton & Loguidice was the firm selected through the Request For Qualifications (RFQ) process; and

WHEREAS, Seneca County desires to contract with Barton & Loguidice to start the work on the project; and

WHEREAS, the funds secured from the New York State Empire Development Corporation will be used for this purpose; and

WHEREAS, the resolution has been reviewed and approved by the Planning, Development, Agriculture & Tourism Committee on June 23, 2015; now, therefore be it

RESOLVED, that the Seneca County Board of Supervisors approves contracting with Barton & Loguidice for an amount not to exceed \$158,000.00; and that the Chairman of the Board of Supervisors be authorized and directed to sign all necessary documentation for the contract, subject to approval of the Seneca County Attorney.

Under discussion of Resolution No. 143-15, Supervisor Churchill questioned why the language did not include the terms of the contract (i.e. amount, start and end dates). The end date could not extend beyond the deadline date of July 31, 2015, when the Consolidated Funding Application (CFA) was due. The cost for engineering services would not exceed \$158,000.

Supervisor Garlick Lorenzetti offered a motion to amend the main motion by inserting the text in the Resolved clause stating the contract would not exceed \$158,000. A second was offered by Supervisor Hayssen. The motion to amend the main motion was carried.



**RESOLUTION AUTHORIZING EXTENSION OF GRANT CONTRACT FOR PAPA BEAR BUILDING RENOVATIONS AT THE HISTORIC COURTHOUSE COMPLEX IN OVID, NEW YORK, COMMONLY KNOWN AS “THE THREE BEARS” COMPLEX**

RESOLUTION NO. 144-15 moved by Mr. Hayssen, second by Mr. Davidson and adopted.

WHEREAS, the New York State Department of State has a contract with Seneca County for the purpose of Papa Bear Renovations; and

WHEREAS, New York State Department of State has agreed to extend the grant contract until July 31, 2016, to allow Seneca County the time to spend the remaining project funds; and

WHEREAS, this resolution has been reviewed and approved by the Planning, Development, Agriculture and Tourism Committee at its June 23, 2015 meeting; now, therefore be it

RESOLVED, that the Chairman of the Board of Supervisors is hereby authorized and directed to sign any and all documents necessary to extend Grant Contract #M061163, Papa Bear Renovations until July 31, 2016, subject to approval of the Seneca County Attorney.

Under discussion of Resolution No. 144-15, it was learned that the balance of the grant is approximately \$7,300 and would be used to purchase a boiler.

**BOARD OF SUPERVISORS REQUESTS PROTECTION OF WHITE DEER HERD**

RESOLUTION NO. 145-15 moved by Mr. Hayssen, second by Mrs. Garlick Lorenzetti and adopted by 625 ayes and 125 nays (Churchill, Kubasik).

WHEREAS, the herd of white deer inhabiting the former Seneca Army Depot has become a well-known and admired fixture at the former depot; and

WHEREAS, the nature of the herd is such that they would be particularly susceptible to depletion if subjected to uncontrolled hunting; and

WHEREAS, for both ecological and sound tourism promotion reasons, it is in the interest of both the State and the County to protect these unique animals from all forms of hunting; and

WHEREAS, this resolution has been approved by the Planning and Development Committee, now, therefore, be it

RESOLVED, that the Board of Supervisors requests that our state representatives introduce and support legislation designed to amend the State Environmental Conservation Law to prohibit all forms of hunting of White Deer, including hunting permissible under a Deer Damage Permit, also known as a “nuisance permit” in the State of New York, or alternatively in the County of Seneca; and be it further

RESOLVED, that a copy of this resolution be provided to Senator Michael F. Nozzolio, Assembly Minority Leader Brian M. Kolb and Assemblyman Phillip A. Palmesano.

Under the discussion of Resolution No. 145-15, Supervisor Kaiser offered a motion to amend the main motion by adding language that would allow hunting of white deer at the depot for the sole purpose

of management of the herd. Supervisor Hayssen objected to Supervisor Kaiser's motion, saying that hunting is not a significant factor in managing the white deer hear. He learned from Steve Absolom, Installation Manager of the former army depot, that the result of hunting reduces an average of 3.5 of 200 white deer at the depot.

**BOARD OF SUPERVISORS TO APPROVE THE CONTRACT WITH BINNACLE TECHNOLOGY SOLUTIONS, LLC FOR REPRESENTATIVE PAYEE SOFTWARE**
